AB 60 Fact Sheet

California Assembly Bill 60 (AB 60) allows eligible applicants to obtain an official California driver license even if they can't prove that they are legally permitted to live in the United States.

Frequently Asked Questions

Who is eligible for a license under AB 60? Every person age 16 and older can get an AB 60 driver license, if that person can't prove that they are legally allowed to live in the United States.

What are the benefits of obtaining a valid driver license? A driver license allows you to drive on California roads. You won't be arrested or given a ticket for driving without a license, and your vehicle won't be impounded. A driver license can be used as official identification when talking to a police officer.

What documents can I use to prove my identity and California residence? Many different documents can be used to prove your identity. For example, a California ID card, a Mexican Federal Electoral card, a Mexican passport, or a Mexican consular card. For more information, visit driversed.com/california/ab60.

How can I study for the written exam? Many different documents can be used to prove that you live in California, including a California ID card, a rental or lease agreement, a utility bill or cellular phone bill, school documents, medical documents, or employment documents. For more information, visit driversed.com/california/ab60.

How can I practice for the driving test? Everything on the written exam can be found in the official California Driver Handbook, provided by the DMV. You can also find printable practice tests at driversed.com/california/ab60. In addition, DriversEd. com provides a quick, FREE online course that will help you learn exactly what you need to pass the written exam on your first try. To sign up for the course and take it any time, visit driversed.com/california/ab60.

How can I practice for the driving test? After you pass the written exam, you'll get an instruction permit. This permit allows you to drive a vehicle **ONLY WHEN** a person age 18 or older, who holds a valid California driver license, rides in the front passenger seat. With an instruction permit, you can practice driving with a licensed adult driver until you feel comfortable taking and passing the driving test.





License checklist

First, get your instruction permit.

- 1. Go to the DMV.
- 2. Fill out form DL 44.
- **3.** Pay the \$33 application fee.
- **4.** Prove your identity and California residence.
- 5. Give your thumbprint.
- **6.** Have your picture taken.
- Pass the vision exam.
- 8. Pass the written exam.
- **9.** Get your instruction permit.

Next, get your driver license.

- 1. Go to the DMV.
- 2. Prove that you have auto insurance.
- 3. Pass the driving test.
 - 4. Receive your driver license.

Quick Tips -

DON'T pay money to anyone but the DMV when applying for a license. The only required fee is paid directly to the DMV.

DON'T pay money to anyone to translate DMV documents. All DMV documents are available in Spanish free of charge.

You should always make an appointment before going to the DMV. You can make an appointment by visiting the DMV's website at dmv.ca.gov, calling 1-(800)-777-0133, or using the DMV Now app on your iPhone or Android device.

Make sure to pay all parking or traffic tickets before applying for a license. The DMV will not give you a license if you have any unpaid fines.

Applying for an AB 60 license will **NOT** cause your immigration status to be investigated. However, if the ICE is already investigating you, they may be able to get your information by asking the DMV for it.
